3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could



be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 29.09.2021 alone stands modified and the petitioner shall appear before the respondent police every Monday at 10.30 a.m till filing charge sheet and thereafter as and when required. All other conditions remain unaltered.
