ORDER : The Court Made the following order :-

The petitioner is A2 in all these cases. He apprehends arrest at the hands of the respondent police for the offence punishable under sections 120B, 409 and 420 of I.P.C r/w Sections 13(1)(d) and 13(2) of the Prevention of Corruption Act, in Crime No.RC/MA1/2019/A0022/ACB/CBI, seeks anticipatory bail.

2. Earlier when the matter was taken up for hearing, M.K.Srinivasan learned Special Public Prosecutor for CBI cases submitted that now the investigation has been completed and final report has been filed and the matter was taken cognizance and summons are issued to the petitioner.

Recording the above submissions, as no further adjudication is required in these petitions these petitions are closed.
