The petitioner has filed this petition seeking to modify the condition directing the petitioner to appear before the respondent police imposed in the order dated 28.09.2021 made in Crl.O.P.No.17968 of 2021.

2.The learned counsel appearing for the petitioner submitted that the petitioner is apprehending to appear before the respondent police and further submitted that the petitioner may be directed to report before the learned Judicial Magistrate, Thiruvottiyur and prayed to modify the said condition.

3.The learned Government Advocate (Crl. Side) submitted that the appearance of the petitioner before the respondent police is necessary for the investigation of the case and if the petitioner did not appear before the respondent police, it will be difficult for the respondent police to conclude the investigation.
