Without expressing any opinion on merits of the writ petition, the second respondent is directed to consider the representation of the petitioners dated 10.08.2021 as per GO.Ms.No.59 dated 21.01.2006 and, after giving them opportunity of hearing, pass orders on merits and in accordance with law within a period of twelve weeks from the date of receipt of copy of this order.

3. With the above direction, this writ petition is disposed of. Consequently, connected miscellaneous petition is closed. No order as to costs.
