2. The order at Paragraph No.8 (a) dated 04.06.2021 passed in Crl.O.P.No.9893 of 2021 which is extracted below:-

8.....

(a). The petitioner shall deposit a sum of Rs.5,000/- (Rupees Five Thousand only) Towards the Covid Relief Fund, in favour of the District Medical Office, Cuddalore.



3. The Learned Counsel for the petitioner states that there is no District Medical Office at Cuddalore. Hence, the petition.
