2. Heard, Ms.AL.Ganthimathi, learned counsel appearing for the petitioner and Mr.A.Selvendran, learned Special Government Pleader appearing for the respondents 1 to 4.

Without going into the merits of the case, the second respondent is directed to complete the enquiry on the appeal filed by the petitioner to cancel the patta issued in favour of the fifth and sixth respondents herein in Na.Ka.No.907/2021/No.1, dated 11.01.2021, after issuance of notice to the fifth and sixth respondents and after giving them opportunity of hearing and pass orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

4. With the above direction, the Writ Petition is disposed of. Consequently, connected Miscellaneous Petition is closed. No costs.
