2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the 1<sup>st</sup> petitioner/Accused 2 has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the 1<sup>st</sup> petitioner/Accused 2 could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 09.08.2021 in respect of the 1<sup>st</sup> petitioner alone stands relaxed and the 1<sup>st</sup> petitioner shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
