3. The learned Additional Public Prosecutor would submit that the petitioner had earlier filed an application for bail in CrI.O.P.No.20870 of 2021 and the same was dismissed by order dated 02.11.2021 and suppressing the same, the petitioner has filed the present petition before this Court.

4. It is seen that the petitioner by suppressing the earlier dismissal order, has filed the present petition before this Court. In view of the above and also taking into account the conduct of the petitioner, this Court is inclined to dismiss the petition with cost.



5. Accordingly, this Criminal Original Petition is dismissed with cost of Rs.2,000/- (Rupees Two Thousand Only) payable to the Legal Services Authority, Tiruvallur.
