2.Learned counsel for the petitioner would submit that the petitioner has filed Crl.R.C.No.285 of 2021 against the judgment of conviction and sentence. He would submit that the petitioner had moved Crl.M.P.No.5733 of 2021 seeking suspension of sentence and this Court by order dated 06.05.2021 was pleased to suspend the sentence and one of the condition imposed was that the petitioner was directed to appear before the trial Court at 10.30 a.m. on the first working day of every week pending revision.
