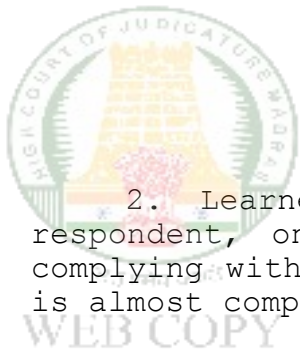

Vide Order dated 31.08.2021, this Court had granted anticipatory bail to the petitioners on certain conditions. This petition has been filed by the petitioners seeking relaxation of the conditions.



2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioners have been complying with the conditions without fail and that the investigation is almost completed.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 31.08.2021 alone stands relaxed and the petitioners shall appear before the respondent police as and when required for interrogation and co-operate with the trial proceedings. All other conditions remain unaltered.
