3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 07.09.2021 alone stands modified and the petitioner shall appear before the respondent police twice in a month i.e., on the first and third Monday of every Month at 10.30 a.m. till the investigation is completed and charge sheet is filed and thereafter, shall appear before the concerned trial Court on each and every date of hearing. All other conditions remain unaltered.
