Vide order dated 13.05.2021, this Court had granted anticipatory bail to the petitioners on certain conditions. This petition has been filed by the petitioners seeking extension of time to surrender before the learned Judicial Magistrate, Poochampalli and for execution of the bond as imposed by this Court.

2. Being satisfied with the reasons shown in the affidavit filed in support of the petition, the prayer sought for by the petitioners deserve to be considered favourably.



3. Accordingly, time is extended by a further period of two weeks from the date of receipt of a copy of this order for the petitioners to surrender before the learned Judicial Magistrate, Poochampalli and for execution of the bond as imposed by this Court. All other conditions remain unaltered.
