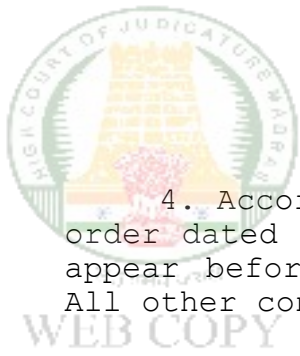

4. Accordingly, the condition insofar as appearance as imposed by order dated 22.10.2021 alone stands modified and the petitioner shall appear before the respondent police on every Monday at 10.30 a.m. All other conditions remain unaltered.
