Therefore, the respondents are directed to consider the representation of the petitioner dated 23.11.2020 and conduct enquiry after issuance of notice to the adjacent land owners and counter parties, if any, and, after giving them opportunity of hearing, pass orders on the petitioner's representation dated 23.11.2020 to survey the land comprising in S.No.285/3 measuring 26 cents, situated at Perumpulipakkam Village, Nemili Taluk, Ranipet District, on merits and in accordance with law, within a period of eight weeks from the date of receipt of copy of this order, on payment of requisite fees.
