3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed on the petitioner by order dated 12.10.2021 stands modified that the petitioner shall appear before the respondent police on first working day of every month until further orders. All other conditions remain unaltered.
