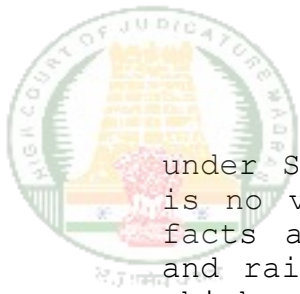

Considering the facts and circumstances of the case that they only assembled and raised the slogan against the New Citizenship Amendment Act which comes under their right of expression. Therefore, this Court, find any prima facie material to quash the proceedings against the petitioner.

Hence, this Criminal Original Petition stands allowed and as a sequel, the charge sheet, pending on the file of the Additional Special Court for Trial of Cases related to Members of Parliament and Members of Legislative Assembly of Tamil Nadu, is quashed.
