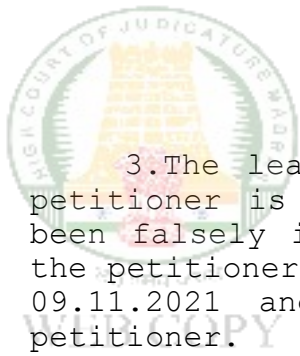
PETITION FOR BAIL 439 Cr.P.C.

ORDER : The Court Made the following order :-

(The case has been heard through video conference)

The petitioner who was arrested and remanded to judicial custody on 09.11.2021 for the offences under Sections 376 and 417 of IPC, in Crime No.36 of 2021, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner on the false promise of marrying the defacto complainant, had sexual intercourse with her on several occasions and thereafter, the petitioner refused to marry her. Therefore, the defacto complainant attempted to commit suicide. Hence, the complaint.



3.The learned counsel for the petitioner would submit that the petitioner is no way connected with the alleged offence and he has been falsely implicated in this case. He would further submit that the petitioner has been suffering incarceration for about 20 days from 09.11.2021 and hence, he would pray for grant of bail to the petitioner.

4.The learned Government Advocate (Crl. Side) would raise strong objection stating that the petitioner on the false promise of marrying the defacto complainant, had sexual intercourse with her on several occasions and thereafter, refused to marry her and that the investigation has not been completed.

5.On seeing the grave nature of allegation levelled against the petitioner and the investigation has not been completed, this Court is not inclined to grant bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
