2. The facts of the case are as follows:

The petitioner has completed her degree in Easwari Engineering College. She applied M.Tech Course and the course was offered to the petitioner by IIT, Hyderabad. She has to pay a fee for the two years at Rs.11,98,700/-, for which, she had



applied for an education loan on 29.07.2021 with the first respondent bank and till date, the application is not processed, the petitioner has filed the present Writ Petition before this Court for seeking appropriate relief.
