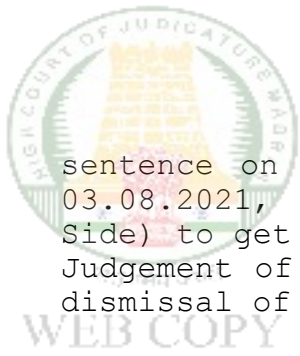

Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S.C.D.SUGUMAR, Advocate for the petitioner and of M/S.S.SUGENDRAN, Government Advocate (Crl.Side) on behalf of the Respondent the court made the following order:-

This application has been filed seeking suspension of sentence.

2. It is seen from the records that the petitioner had earlier moved Crl.M.P.No.7065 of 2021 seeking for suspension of sentence. This Court, after hearing the counsel and after perusing the materials available on record, had dismissed the application for suspension of



sentence on merits. Thereafter when the matter had been listed on 03.08.2021, this Court had directed the Government Advocate (Crl. Side) to get instruction from the Jurisdictional Police to execute the Judgement of the appellate Court and secure the petitioner. After the dismissal of the petition, there is no change of circumstances.

3. In view of the above, this Criminal Miscellaneous Petition stands dismissed. The respondent is directed to comply with the order of this Court dated 03.08.2021.
