Vide Order dated 24.09.2021, this Court had modified the condition for relaxation as imposed by the petitioner. This petition has been filed by the petitioner seeking further relaxation of the conditions.

2. Learned Additional Public Prosecutor appearing for the respondent submits that the charge sheet has not been filed. However, it is submitted that the petitioner is complying with the conditions.

In view of the above submission, considering that this Court by its order dated 24.09.2021, modified the condition as imposed by the petitioner that to appear before the respondent police on every Monday at 10.30 a.m till filing of the charge sheet. Since, the charge sheet has not been filed, this Court is of the considered view that the prayer as sought for by the petitioner could not be acceded to. Accordingly, this Criminal Miscellaneous Petition is dismissed.
