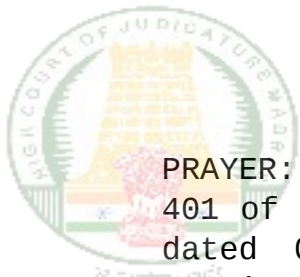

The revision petitioner is the defacto complainant, he appears to have filed a petition in CrI.M.P.No.80 of 2015, before the Court of the learned Principal District and Sessions Judge, Perambalur, under Section 408 (1 & 2) of Cr.P.C r/w Section 14(1) and (3) of the Schedule Castes and Scheduled Tribes (Prevention of Atrocities) (Amendment) Ordinance 2014, for transfer of the case in P.R.C.No.19 of 2009 from the file of the learned Judicial Magistrate, Perambalur to the Sub-Court, Perambalur. The said petition was dismissed for default. Against the same, he has filed the Criminal Revision Case before this Court.

2.The learned Government Advocate (CrI.Side) would contend that PRC.No.19 of 2009, before the learned Judicial Magistrate, Perambalur was committed to the learned Special Judge for SC/ST Special Court and renumbered as Spl.S.C.No.28 of 2018 and the matter was posted for trial.
