4.This court by order dated 06.05.2021 had directed the petitioner to deposit Rs.3,00,000/- to the credit of S.T.C.No.5875 of 2015 on the file of the learned Judicial Magistrate No.1, Bhavani within a period of eight weeks from the date of receipt of a copy of this order. This Court is not inclined to modify the condition in view of the fact that the cheque amount involved in this case is Rs.14 lakhs. However, time is further extended by four weeks to comply with the order dated 06.05.2021 in CrI.M.P.No.5725 of 2021.With the above direction, the petition is closed.
