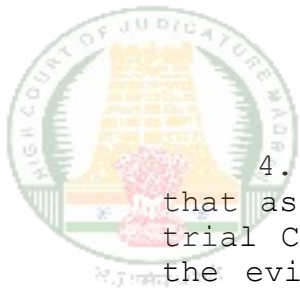

This Criminal Original Petition has been filed to call for the records, in C.C.No.874 of 2016, on the file of the Judicial Magistrate, Alandur, Chennai-16, quash the proceedings.

2. Heard Mr.K.S.Kumar, learned counsel for the petitioner, Mr.S.Vinoth Kumar, learned counsel for Public Prosecutor for Respondent 1 and Mrs.C.Shyamala, learned counsel for the respondent 2.

3. Mr.S.Vinoth Kumar, learned counsel appearing for Public Prosecutor for R.1 submitted that out of six witnesses, four witnesses have been examined.

In such a view of the matter, this Court is of the view that as the evidence is almost completed before the trial Court, trial Court has to appreciate the evidence and find out whether the evidence constitute any of the offences.
