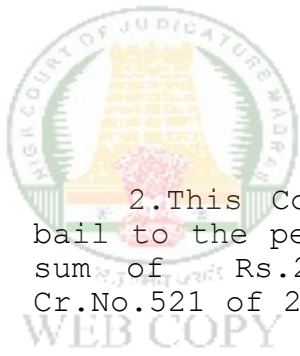

Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S P.MUTHAMIZHSELVAKUMAR, Advocate for the Petitioners and of MR.S.BALAJI, Govt. Advocate (Crl. Side) on behalf of the Respondent the court made the following order:-

This petition is filed to modify the condition imposed on the petitioners by this Court in Crl.O.P.No.15913 of 2021, dated 14.09.2021.



2. This Court vide order dated 14.09.2021, granted anticipatory bail to the petitioners on condition that the petitioners shall pay a sum of Rs.2,00,000/- (Rupees One Lakh Only) to the credit of Cr.No.521 of 2021 on the file of the respondent police.

3. Today, when the matter is taken up for hearing, the learned counsel appearing for the petitioners submitted that the petitioners is unable to comply the condition in clause (b) of para 6 in order dated 14.09.2021. Hence, the present modification petition is filed by the petitioners to modify the conditions imposed on the petitioners terming the same to be onerous.

4. This Court had granted anticipatory bail to the petitioners, as the petitioners on their own volition were ready to deposit the above said amount to the credit of the Cr.No.521 of 2021. Therefore, the petitioners cannot now claim that the said condition is onerous and seeking modification of the above condition is impermissible. Hence, the present petition seeking modification stands dismissed.
