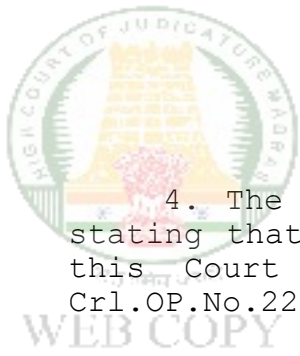
PETITION FOR BAIL 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners who were arrested and remanded to judicial custody on 04.11.2021 for the offence under 294(b), 353, 328, 506(i), of IPC r/w Section 24(1) of COTP Act, in Crime No.721 of 2021, on the file of the respondent police, seek bail.

2. The case of the prosecution is that on 04.05.2021 during regular check up, the respondent police found the petitioners transporting contraband tobacco products in gunny bags worth about Rs.5,55,250/- .Hence the complaint.

3. The learned counsel for the petitioners would submit that the petitioners have not committed any offence as alleged by the prosecution and they have been falsely implicated in this case. He would further submits that the petitioners have been suffering incarceration for 40 days from 04.11.2021 . He would pray for grant of bail to the petitioners.



4. The learned Government Advocate (Crl. Side) raised objection stating that investigation is not completed. He further submits that this Court dismissed the petitioner's earlier bail petition in Crl.OP.No.22528 of 2021 dated 26.11.2021.

5. Considering the above fact that quantity of the alleged products and grave nature of the offence and there is no change of circumstances after dismissal of the petitioner's earlier bail petition, this Court is not inclined to grant bail to the petitioners.

6. Accordingly, this Criminal Original Petition is dismissed.
