2. The learned Additional Public Prosecutor submitted that the petitioner is complying with the condition regularly imposed by this Court.

Considering the said submission, the condition imposed on the petitioner is modified to that effect, that the petitioner undertake that he will return to India and surrender his passport before the Special Court for the cases under the Prevention of Corruption Act, Chennai, for three months from the date of boarding. All other conditions remain unaltered.
