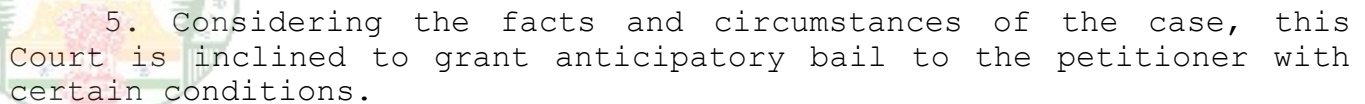
O R D E R

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offences under Section 24(1) of Tobacco Act in Crime No.418 of 2021, seeks anticipatory bail.

2. The case of the prosecution is that on 01.11.2021 the respondent police recovered of Hans 176 Kg, MDM 26 Kg, Coollip - 25 Kg from the petitioner's premises which are banned tobacco products. Hence the complaint.

3. The learned counsel appearing for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case. Hence, he prays for grant of anticipatory bail.

4. The learned Additional Public Prosecutor appearing for the respondent submitted that no previous case pending against the petitioner. However, he vehemently opposed to grant anticipatory bail to the petitioner.



[a] the petitioner are directed to deposit a sum of Rs.10,000/- (Rupees Ten Thousand only) to the credit of the Society for the Educational and Economic Development (SEED) Reg., Sriperumbudur, Account Name: SEED, A/c.2926101000002, Canara Bank, Sriperumbudur, IFSC CNRB0002926, Cell No. 9944812053 within a period of two weeks from the date of receipt of a copy of this order and shall produce the said receipt before the Court below.

[c] the petitioner is directed to report before the respondent police daily at 10.30 a.m., until further orders;

[e] the petitioner shall not abscond either during investigation or trial.
