3. The punja land of an extent of 0.33.0 ares (0.82 cents) in survey no.131/6 of Alathur Village, Sankarapuram Taluk, Kallakurichi District (erstwhile Villupuram District) was



originally assigned by order dated 31.10.2001 by the Tahsildar. However, the same was cancelled and aggrieved by the same, the petitioner filed appeal before the second respondent and it is pending in appeal No.Au4/78/2019.
