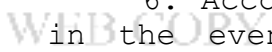
ORDER

The petitioner, who apprehends arrest for the alleged offences under sections 379, 430 of the Indian Penal Code and Section 21(1) of the Mines and Minerals (Development and Regulation) Act, 1957, in Crime No.745 of 2021, on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner illegally transported one unit of river sand in a Mahendra Tractor bearing registration No. TN-25-BY-8403. Hence, the Law Enforcing Agency registered a case against the petitioner.

3. The learned counsel appearing for the petitioner would submit that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. Hence, he prays for grant of anticipatory bail to the petitioners.

4. The learned Additional Public Prosecutor submits that the petitioner illegally transported one unit of river sand. Hence, he opposed for grant of anticipatory bail to the petitioner.
