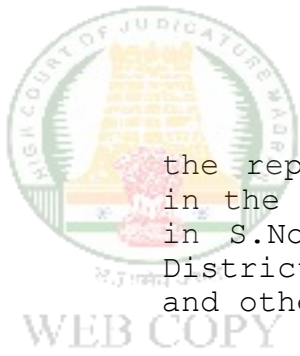

ORDER

This Writ Petition has been filed for the issuance of Writ of Mandamus, to direct the respondents 1 to 3 to consider

Considering the above, the Revenue Divisional Officer, Ulunthurpet Taluk, Kallakurichi District, is directed to issue notice to the petitioner and the fourth respondent herein, after giving an opportunity of hearing to them, dispose the same on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

5. With the above directions, this writ petition is disposed of. There shall be no order as to costs.
