ORDER

This petition has been filed seeking a direction, to direct the learned Principal District and Sessions Judge, Ariyalur to consider the bail application on merits on the same day on the petitioner's surrender in connection with Cr.No.864 of 2021 pending investigation on the file of the respondent police

In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioner is directed to surrender before the trial Court within a period of two weeks from the date of receipt of a copy of this order or after commencement of normal functioning of the Court, which ever is later and on such surrender, the learned **Principal District and Sessions Judge, Ariyalur,**
