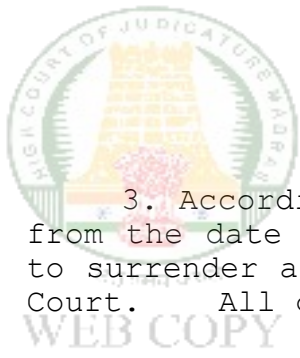

Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S P.KANNAN, Advocate for the Petitioners and of MR.A.GOKULAKRISHNAN, Additional public Prosecutor on behalf of the Respondent and of M/S.N.PONRAJ, Advocate for Intervenor the court made the following order:-

Vide order dated 18.11.2021, this Court has granted time for a period of two weeks to make a payment of Rs.50 Lakhs and to surrender before the lower Court. This petition has been filed by the petitioners seeking further extension of time for a period of 2 weeks to surrender and to deposit an amount of Rs.50 Lakhs before the lower Court.

2. Being satisfied with the reasons shown in the affidavit filed in support of the petition, the prayer sought for by the petitioners deserve to be considered favourably.



3. Accordingly, time is extended by a further period of two weeks from the date of receipt of a copy of this order for the petitioners to surrender and to deposit an amount of Rs.50 Lakhs before the lower Court. All other conditions remain unaltered.
