PRAYER in W.P.No.7387/2017: Writ Petition filed under Article 226 of Constitution of India, praying to issue a writ of certiorarified mandamus, to call for the records relating to the impugned Government Order issued by the 1st respondent in G.O.Ms.No.134 School Education, Thu.Nu.2 Department dated 18.08.2015 and to quash the same and consequently directing the respondents to grant renewal of Recognition/Permanent Recognition for the member schools of Petitioner Association in compliance to the provisions of Matriculation Code for the period from 31.05.2016, within a time frame to be fixed by this Hon'ble Court.

PRAYER in W.P.No.17016/2017:Writ Petition filed under Article 226 of Constitution of India, praying to issue a writ of mandamus, to direct the 1st respondent to pass orders for granting opening permission for Ixth and Xth standards based on the application submitted by the petitioner school dated 28.12.2016, based on the plan approval granted by Unnamalaikadai Town Panchayat without insisting for plan approval from DTCP in the light of the orders passed in W.P.(MD).No.13152 of 2015 dated 28.07.2015 confirmed in the orders passed in W.A.(M.D). No.1139 of 2015 dated 02.12.2015, within a time fraxe to be fixed by this Hon'ble Court.
