These civil revision petitions are filed against the fair and decretal order dated 17.09.2016 in IA.Nos.229 & 230 of 2016 in

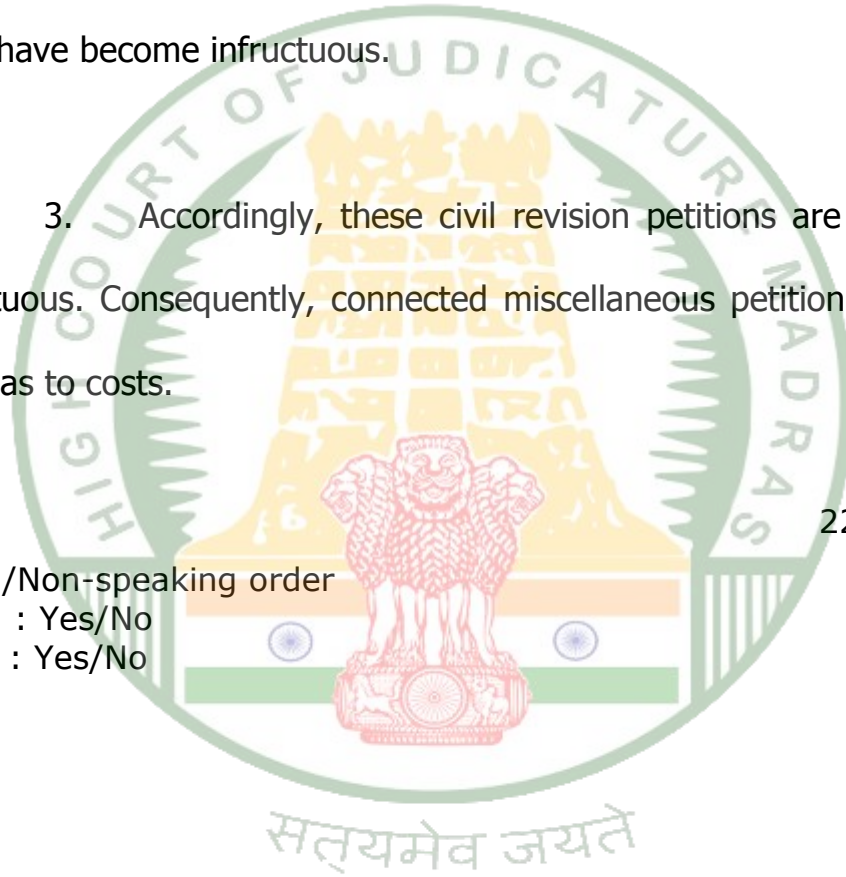
OS.No.501 of 2010 on the file of the V Additional District Court, Coimbatore.

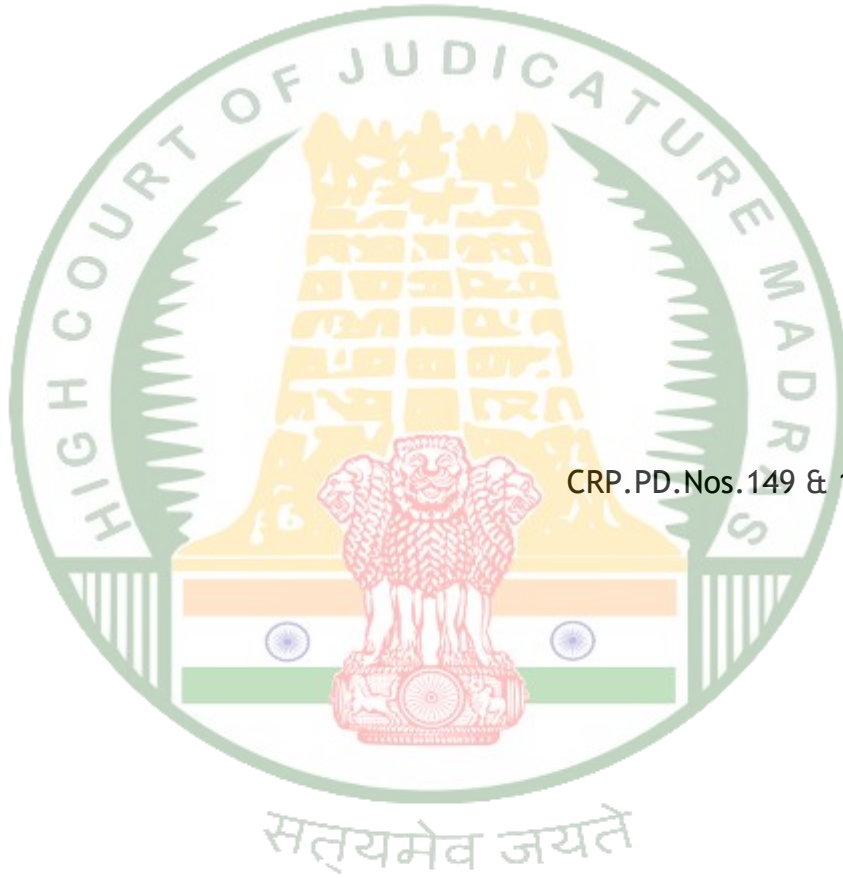
