This Court, by order dated 08.11.2016, disposed the writ petition with a direction to the second respondent to issue notice to the parties and pass appropriate order as per the procedure contemplated under Circular – 67 of the Inspector General of Registration.

3. In the counter affidavit filed by the second respondent it is stated that by proceedings dated 15.09.2017, the second respondent has declined to cancel the registration of document as requested by the petitioner.



4. On the basis of the statement found in the counter affidavit filed by the second respondent, reporting compliance, this contempt petition is closed. No costs.
