Today, when the case is taken up for hearing, the learned Government Advocate (Criminal Side) appearing for the respondent/state, on instructions, submitted that the accused persons have already been convicted in S.C.No.348 of 2015 dated 04.08.2021 before the I Additional Sessions Judge, City Civil Court, Chennai - 600 104. He has also produced a copy of the judgment before this Court, pronounced by the Trial Court and the same was recorded. Therefore, the prayer sought for by the petitioners/accused has now become infructuous.
