2. Heard Mr.R.Bharath Kumar, learned counsel appearing for the petitioner and Mr.M.R.Gokul Krishnan, learned Government Advocate appearing for the respondents.

Without expressing any opinion on the merits of the writ petition, the first respondent is directed to consider the representation of the petitioner dated 12.06.2017, after issuance of notice to the petitioner and the counter parties if any and after giving them an opportunity of hearing and pass orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

4. With the above direction, this writ petition is disposed of. There shall be no order as to costs.
