second respondent and consequential agreement dated 14.11.2016 between the petitioner and third respondent and proceedings dated 23.11.2016 of the 2nd respondent made in Se.Mu.Na.No.983/E/2016.

It is seen from the prayers of both the writ petitions that the relief sought for by the respective petitioners have become infructuous as the respective petitioners seek permission to do fishing activities in Varattaupallam Tank in Erode District till 30.06.2017.
