O R D E R

As against the original order dated 12.03.2015 passed by the 1st respondent herein, rejecting petitioner's request for Compassionate appointment, the petitioner had preferred an



appeal on 20.08.2016 to the 2nd respondent herein and same is pending. While that being so, it would not be appropriate to parallelly adjudicate the present Writ Petition. However, if the Appellate Authority is directed to complete the appeal proceedings within a stipulated time, the ends of justice could be secured.

2. In the light of the above observation and without going into the merits of the petitioner's claim, there shall be a direction to the 2nd respondent herein to complete the appeal proceedings and pass final orders within a period of 3 months from the date of receipt of a copy of this order. The Writ Petition is disposed of, accordingly. No costs.
