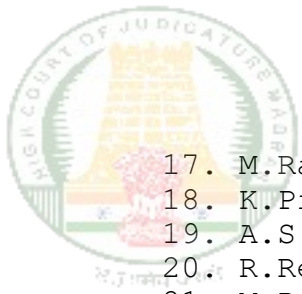

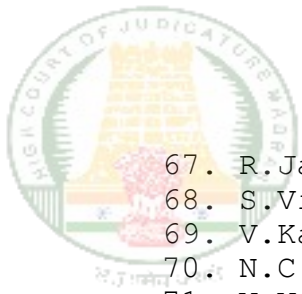

ORDER
