Even today i.e. 27.07.2021, no one appeared on behalf of the petitioners.

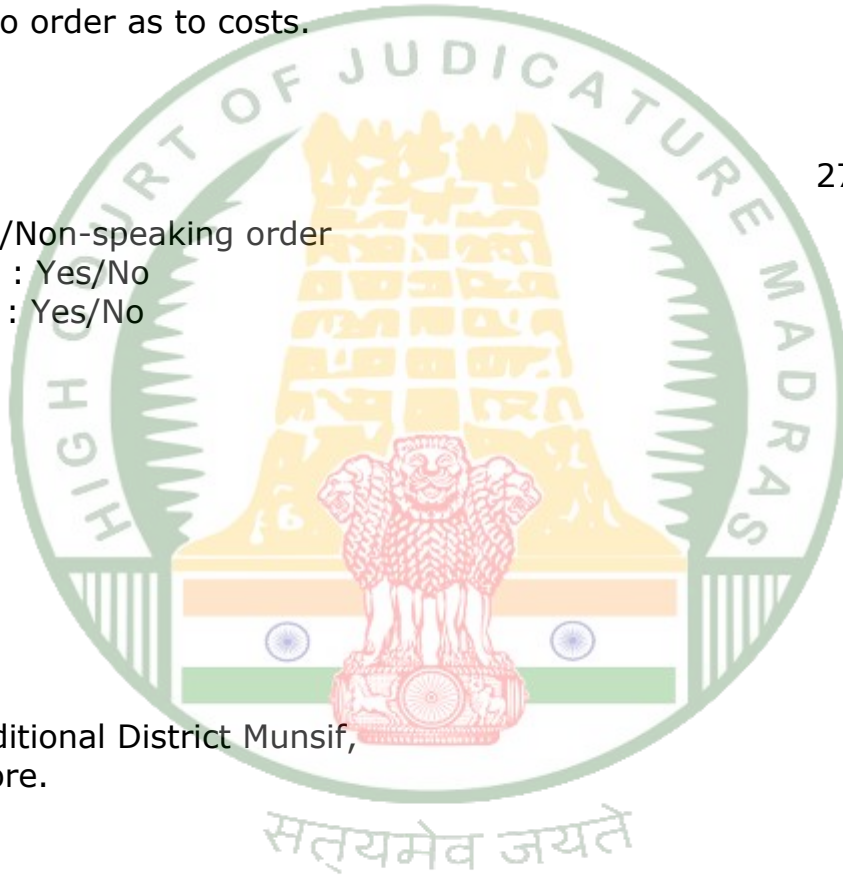
3. Therefore, the civil revision petition is dismissed for non prosecution. Consequently, connected miscellaneous petition is closed. No order as to costs.

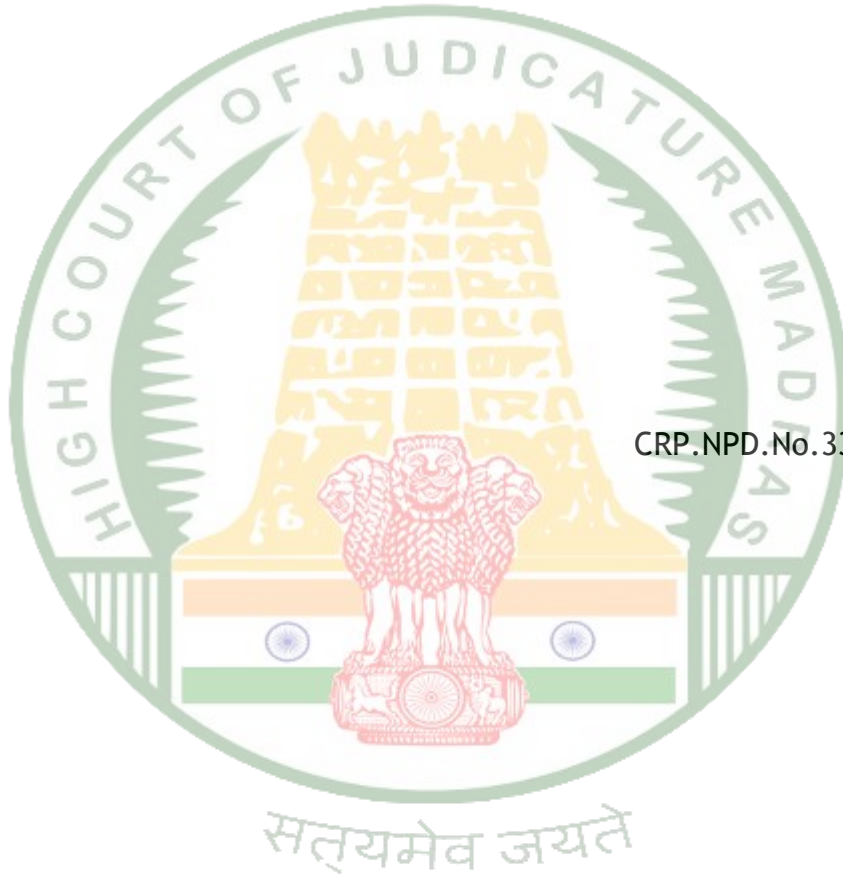
