This Writ Petition has been filed, seeking for issuance of a Writ of Certiorarified Mandamus to quash the proceedings in Lr.No.01/2018/V.Tho.A. dated 14.09.2018 passed by the 2nd respondent and consequently direct the respondents to consider petitioner's representations dated 12.05.2018, 28.05.2018 and 02.07.2018 made to change the proposal for laying the Mangalampettai By-pass road (SH 69).



2. When the matter is taken up for hearing today, i.e., 24.11.2021, none appeared on behalf of the petitioner. However, Mr.K.M.D.Muhilan, learned Government Advocate for the respondents would submit that, already alignment has been made and almost 80% of work has been completed. Therefore, the prayer sought for in this Writ Petition has become infructuous.

3. Since the prayer sought for in this Writ Petition has become infructuous, probably, this might be the reason for the non appearance of the petitioner to prosecute the case.
