His further submission is that he has submitted a representation dated 14.12.2020 to the respondents seeking permission to conduct the said Game and so far, no action has been taken by the respondents.

4. In the circumstances, without going into the merits of the claim made by the petitioner, this Court directs the second respondent to consider the representation of the petitioner and pass appropriate orders in accordance with law as early as possible.



5. With the above observations, this petition is disposed of.
