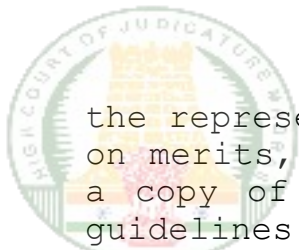

Assistant Commissioner of Police, Annanagar (L&O) Range, Madurai City, Madurai and Others** reported in 2018 4 MLJ (Cr1) 585 and **Thirumagan Vs. The Superintendent of Police, Madurai District** reported in 2020 (2) LW (Cr1) - 266.

4.With the above observation, this writ petition is disposed of. No costs.
