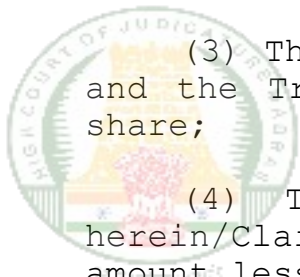

DECREE:-

(1) That the the judgment and decree dated 12.02.2009 made in MCOP No.920 of 2004 on the file of the Motor Accident Claims Tribunal / Additional Subordinate Court, Dindigul. be and hereby is confirmed and the Civil Miscellaneous Appeal is dismissed;

(2) That the Appellant/Insurance Company be and hereby is directed to deposit the entire award amount with accrued interest and costs, less the amount already deposited, if any, within a period of eight weeks from the date of receipt of a copy of the Judgment;



(3) That the 1st Respondent herein/Claimant is declared as major and the Tribunal below be and hereby is directed to disburse her share;

(4) That on such deposit being made, the 1st Respondent herein/Claimant be and is hereby permitted to withdraw the amount, less the amount already withdrawn, if any, together with proportionate interest and costs; and

(4) That there be no costs in this Civil Miscellaneous Appeal.
