(2) And that be no costs in this Civil Miscellaneous Appeal.

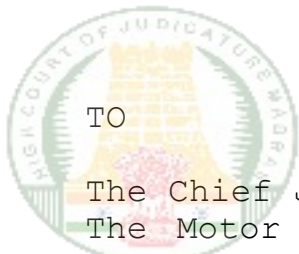
