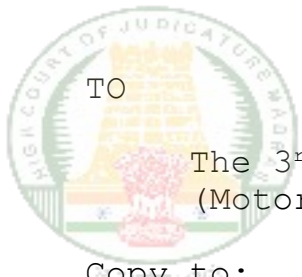
(3) That the Claimant be and hereby is entitled to get Compensation awarded by the Tribunal below with interest and;
