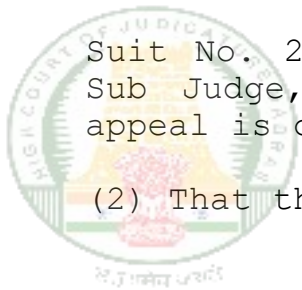
**Prayer:-**
