Prayer in WP(MD). 6903 of 2019 :

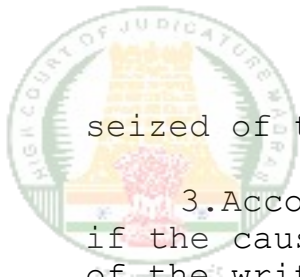
