ii) that there be no costs in this Second Appeal.

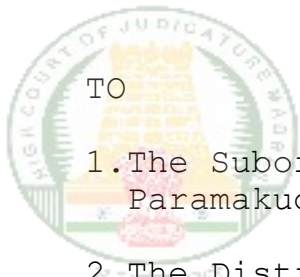
